In consideration of my child being permitted to participate in the Activity, I, on my own behalf and on behalf of my child, hereby RELEASE AND DISCHARGE People of Praise, Inc., its respective officers, directors, agents, employees, volunteers, or anyone else acting on its behalf (collectively, "People of Praise") from any and all claims, demands or actions for personal injury, property damage or any other damage or loss which may be caused by any act or failure to act, including negligence by People of Praise, which may arise out of or relate to my child's participation in the Activity, to the extent that such damage or loss exceeds the liability insurance coverage of the People of Praise. I understand and acknowledge that participating in the Activity may expose my child to dangers from both known and unanticipated risks, whether existing because of negligence or otherwise (including but not limited to the negligence of People of Praise), and I, on my own behalf and on behalf of my child, specifically waive any and all claims against People of Praise arising out of such conditions. In signing this Agreement, I fully recognize that if my child is injured or suffers any other loss as a result of participating in the Activity, neither I (on my own behalf or on behalf of my child), nor my child will have a right to make any claim or file any lawsuit against People of Praise for an amount in excess of the liability insurance coverage of the People of Praise, as described in the next paragraph. I, for myself, my heirs, my next of kin (including my child's other parent or guardian), assignees, executors and administrators of my or my child's estate, do hereby state and expressly agree that People of Praise is under no obligation for my child's care and shall not be liable for the consequences of conduct that would otherwise be negligent.

I understand and expressly agree, on my behalf or on behalf of my child, that the foregoing provisions are intended to be as broad and inclusive as is permitted by law; except that the Agreement is not intended to limit, decrease, release or discharge my child's right or ability to make a claim for or recover from: (1) the liability limits of any insurance policy that provides liability coverage to People of Praise for the Activity and the claim, but only up to applicable limits of liability coverage; or (2) any other insurance that provides coverage to any other person or entity for the Activity and the claim. If any portion of this Agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I am aware that by signing this Agreement, I am waiving certain legal rights which, I, my child, my heirs, next of kin (including my child's other parent or guardian), assignees, executors and administrators of my or my child's estate, may have against People of Praise, and I freely and voluntarily sign without inducement. I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, AND VOLUNTARILY AND KNOWINGLY AGREE TO ITS TERMS.
